



NORTH EAST INTERNET GOVERNANCE (NEIG) 2023

The goal of the North East Internet Governance (NEIG) is to engage individuals from various stakeholder groups in, of and for North East Region (NER) of India in talks on Internet-related public policy issues in NER on an equal footing. The NEIG seeks to educate and motivate individuals in charge of developing policy in both the public and corporate sectors, even when there is no agreed-upon outcome. Delegates are expected to converse, share knowledge, and share best practices with one another at their regular and annual gathering. The NEIG seeks to promote a shared understanding of how to make use of online opportunities while addressing potential hazards and difficulties. The NEIG seeks to follow the broad principles and approaches of the Global Internet Governance Forum (IGF) and the India Internet Governance Forum (IIGF).

Objectives

- Discuss public policy problems relating to essential aspects of Internet governance in NER in order to promote the Internet's reach, sustainability, robustness, security, stability, and progress in the distinct topography and landlocked region;
- Promote and facilitate discourse between stakeholders dealing with different cross-cutting themes and aspects of public policies regarding the Internet specific to the region;
- Engage and interface with appropriate organizations and other institutions on matters related to internet in the North Eastern States and the region;

- Support and facilitate the exchange of information and best practices around Internet governance and development;
- Engage and discuss with relevant stakeholders in proposing ways and means to accelerate the availability and affordability of the Internet in the region;
- Observe, scout, identify, map emerging issues in Internet in the region, bring them to the attention of the relevant bodies and the wider public, and, where appropriate, make suggestions and recommendations;
- Work towards contributing to awareness and capacity building for Internet governance in each of the eight States of the region as well as the region as a whole, drawing fully on local sources of knowledge and expertise;
- Promote and assess, on an ongoing basis, the embodiment of WSIS principles in Internet governance processes in the region;
- Discuss issues relating to critical Internet resources for the region; help to find solutions to the issues arising from the use and misuse of the Internet, of particular concern to everyday users;
- Publish its proceedings, disseminate for wider review and referenc

NEIG State Discussion Series 2023

The Council for Social and Digital Development (CSDD), the North East Development Foundation, and the Digital Empowerment Foundation (DEF) are organising a **series of stakeholders' engagements State wise in the region from February 2023 until October 2023.**
